#### Job Summary:

The Education and Quality Coaching Specialist will provide teaching staff with individualized and group based coaching and technical assistance so as to enhance the learning environment and experience of the children served. The E & QCS ensures complete implementation of developmentally appropriate classroom curriculum including environmental and formative assessment (CLASS and Teaching Strategies Gold) for Early Head Start and/or School Readiness/VPK preschool and family childcare homes classrooms.

#### Essential Duties and Responsibilities:

- Ensure fidelity to developmentally appropriate curriculum and assessment models. (Creative Curriculum, Teaching Strategies Gold, CLASS) and others as applicable.
- Ensure fidelity to Early Head Start, QRIS, or VPK early learning and performance standards
- Conduct formal ongoing assessments of classroom learning environments
- Utilize CLASS and TS Gold data to support teachers in developing appropriate teaching techniques
- Provide individualized coaching to teachers to analyze individual and classroom child outcomes data to support child learning
- Ensure all program elements are developed, implemented and accomplished
- Provide leadership and direction to early childhood teachers
- Present at local and state conferences in the areas of curriculum and assessment.
- Work collaboratively across department at the ELC and across agencies in the greater Miami area
- Responsible for the use of an agency paid cell phone and/or P.D.A.-I phone device
- Participate in and support ELC projects as identified
- Assist with projects as assigned by the Director of Training and Education
- 30% or more travel will be required if needed
- Perform related duties as required
