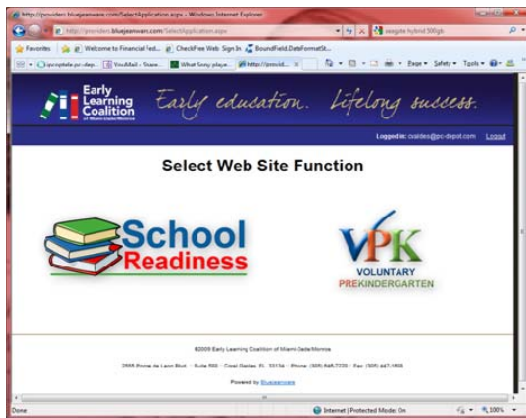
VPK Summer 2011

Applications are being accepted until May 13, 2011. Please visit www.vpkhelp.org and click on the "Forms and Policies" link under the Providers menu. The new AWI forms are located in the "Summer 2011 and School Year 2011-2012 Forms" section.

Please submit your documents through the ELC's Provider Portal (see below) as they are no longer being accepted via email.

VPK School Year 2011-2012

ALL VPK providers for the school year program should submit the **new AWI VPK Forms 10,11 A & B, Provider Agreement, and Attachment A**. Providers must submit their applications online at <http://providers.elcndm.org/Login.aspx>.

Once you have accessed the VPK website, click on the VPK logo (see Picture 1). You will then be taken to a new page where you will click on "Year Round VPK Application Files" (see Picture 2).

Providers who wish to receive an August pre-payment: Your applications are currently being accepted through June 4, 2011. For all others, the deadline to submit your application in order to start on the first day of the new school year is July 23, 2011. No exceptions. Providers who miss these deadlines must wait until the next application period in October.

2009-2010 LPP

You must log on to the VPK Readiness Rate website at <http://vpk.fldoe.org> and complete the Acknowledgement. The deadline to submit this form was April 5, 2011, but we will continue to

accept it until April 27, 2011.

Once this step has been completed, you must next submit an Improvement Plan. Please note however that there has been a delay and the plan is not yet available for completion. As a result, providers are asked to check the website periodically for updates. There is a possibility the Improvement Plan deadline of May 16, 2011 may be extended.

VPK May and June Payments

As always there will be no pre-payment for these two months as we will need to make the adjustments to close out the year. Please plan accordingly.

Provider Application Training
