## READINESS RATES!!

The final 06-07 Provider Readiness Rates will be posted on February 15, 2008. They can be viewed at [vpk.fldoe.org](http://vpk.fldoe.org). The State Board of Education will set the minimum rate on February 19, 2008.

## Managed Enrollment for School Readiness

Families wanting to apply for School Readiness services can obtain information by contacting Resource and Referral at 305-373-3521. Families may also register for the Wait List (not yet determined eligible) online at <https://spe.schoolreadiness.org/pe/>. Families on the Wait List will be served as funding continues to be available. Please be reminded that having an appointment or being on the Wait List **does not guarantee enrollment** because of limited funding. If slots are not available at the time of the eligibility appointment due to funding limitations, families will have their eligibility determined and placed on the Ready Pool if eligible. As soon as slots are available families will be called back in the order they were placed on the Ready Pool to receive their enrollment certificate. Families have 10 days from the eligibility date to register their child or the eligibility certificate becomes void.

The "Buckle Up For Life" training is an educational, 1 hour class for parents and caregivers and is geared at increasing car safety awareness by understanding what happens in a crash and the proper use of seat belts, car seats and boosters. These trainings will be held at the agencies locations with one hour long sessions in English, Creole or Spanish. Refreshments will be provided!!



Following the training, parents and care givers can have their car seats checked by a Certified Passenger Safety Technician and will learn how to install their seats correctly. ### Funding Formula Update

The Agency for Workforce Innovation has submitted the approved funding formula to the Legislature and the Governor. The funding formula establishes how new dollars will be distributed among Coalitions. The formula is performance and equity based and provides a minimum of one percent of the base allocation to each Coalition. For Miami-Dade/Monroe Counties the one percent is just over one million dollars. Once the one percent minimum has been allocated to each Coalition, the formula will be applied for the distribution of the remaining dollars. The conditions under which the Association for Early Learning Coalitions agreed to the formula are as follows: 1) formula would only be applied to new dollars allocated by the legislature; 2) no Coalition would lose any of their existing base allocation unless there was an across the board/statewide reduction in the overall School Readiness budget; 3) the formula would only be applied to the Agency for Workforce Innovation's 2008 legislative budget request of \$15 million; 4) the Association for Early Learning Coalitions would continue to work with AWI to refine the formula.

### English Language Learners VPK Classroom Learning Module

Having the skills and competencies related to maintaining a high quality, culturally sensitive educational environment is essential for providers and teachers of VPK Education Programs. To facilitate this, the Department of Education has developed a self-paced training titled *English Language Learners in the VPK Classroom*. This training is now available at **no cost** and accessible at [www.flvpkonline.org/ELL/](http://www.flvpkonline.org/ELL/). The ideas presented in this learning module are designed to provide a better understanding of the characteristics and language learning experiences of colleagues, staff, children and families who are English language learners. All early childhood educators are encouraged to participate in the training.

### Gold Seal Quality Care Certificates Information

The Florida Department of Children and Families Child Care Program office entered into a contract agreement with the Children's Forum ([www.thechildrensforum.com](http://www.thechildrensforum.com)) to assist the Department with the issuance of Gold Seal Quality Care certificates to providers who have met Gold Seal standards.

**Monroe Provider Rate Increase** At the January 25<sup>th</sup> meeting, the ELC board approved the Monroe provider rate increase effective February 2008. The new full time center and family child care home rates are as follows

**Monroe Quality Initiative Package** At the January 25<sup>th</sup> meeting, the ELC board approved a comprehensive quality initiative package for Monroe providers totaling \$325,000. Through this initiative, Wesley House Family Services will be providing mini grants, training stipends, additional training options and related support to providers. Additionally, initial planning for a quality rating system will seek providers' input through focus groups to develop a plan for increasing and supporting quality early care and education in Monroe County.
