III. Little Yvena's Garden Learning World Center **B. de la Fuente**

- B. de la Fuente stated that Little Yvena's Garden Learning World Center Provider did not administer Assessment Period 1 (AP1) for the 2019-2020 and 2020-2021 School Year. Provider was approved to start Voluntary Pre-Kindergarten on 08/19/2019; however, they did not receive their fourth child until 09/23/2019 and did not notify the ELC to change their start date. Provider did not request a Provider ID; however, did sign a VPK contract where it states and provider agrees to implement the VPK pre and post-



assessment. An email blast was sent out on August 27, 2019 and September 24, 2020 reminding providers to administer AP1. On September 23, 2020 during the Provider meeting, Providers were reminded of Assessment period AP1.

- E. Erched stated that she reached out to OEL in an attempt to obtain a waiver but OEL confirmed that since the Provider had no data for these years, provider would not be issued an ID, therefore, in violation of their contract.
- Y. Simon stated that she had attempted to obtain a provider number but did not receive a return phone call after leaving several messages.
- After reviewing all documents and hearing the providers' testimony, the committee, voted to terminate the VPK contract and revoke eligibility for five years.
